

Travel Agreement

agreement between

Stredná odborná škola – Szakközépiskola Rákócziho 23, Kráľovský Chlmec (address: Rákócziho 23, 077 01 Kráľovský Chlmec) acting on behalf of Ing. Ivan Beňo (director) as the Mandator

And

Medium Consult Kft. (address: 5630 Békés, Kölcsey u. 1.. Vat Number: 140367070. Acting on behalf of: Papp Csaba, travel organisation director), as the Mandatory, which came into effect on today's date, under the following conditions:

1. Under the Leonardo da Vinci Mobility Program (Project Number: 133210463) the Mandatory undertakes the travel transport of 14 persons travelling to Budapest according to the following conditions:
 - On the 22., September, 2013 from Kráľovský Chlmec to Budapest and returning the group to Kráľovský Chlmec , at sending organization
2. The agreement came into force between the contracting parties by the day of the contract being signed by both of the parties and is in effect till the completion of the travel, that is the 12., October 2013.
3. The Mandator shall pay the following charges for the services of the Mandatory:
 - For the travel transport between Kráľovský Chlmec –Budapest- Kráľovský Chlmec 840,-€,
4. The Mandatory shall provide the Mandator with an invoices being attached to the contract. The invoice is sent by The Mandatory to The Mandator 10 days before the start of the travel. The invoice is issued and signed on the The Mandator is required to settle the payment of the invoice within 5 days before the start of travel.
5. The Mandatory is obliged to follow the Mandator's instructions and to inform the Mandator about all the circumstances obstructing the accomplishment of the assignment.
6. If the Mandatory through no fault of his own or the passenger manifest is not completed at the definite time of the departure, the travel will realize according to the passenger manifest not completed.
7. The contract is issued in 3 identical copies which are signed and endorsed by both the Mandator and the Mandatory.
